#### Introduction

It was set up in the year 1997 by Prestige Education Society, Indore registered under the Societies Registration Act 1860. The Society was setup by Prestige Group of Industries with an objective to meet the widely felt need for globally oriented Management and Information Technology education and training for professionals. The Institute has grown to be recognized as a premier Institute for higher learning. It is a major learning center in Central India. The Institute has approval of All India Council for Technical Education, BCI & the State Government and is affiliated to Jiwaji University, Gwalior and RGPV, Bhopal.
