Minutes of the Meeting

- The Chairperson presented a report on identified industry experts for syllabus updation. The board suggested to proceed with the plan and present the industry aligned syllabus for further approval.
- The board also suggested removing the redundancy in the courses' syllabus with the help of functional heads and team.
- The revised curriculum for BBA as per the NEP 2020 was shared amongst the committee members and approved with minor revisions. Board resolved to add all the proposed new courses from the year 2022.
- After thorough deliberation, the board authorized the Controller of Examination to form a dedicated team for the implementation of CO-PO mapping across all

programs. It was agreed that question papers will be framed with explicit mapping of Course Outcomes to ensure alignment and assessment accuracy.

- The board appreciated the inclusion of more value added courses that align with current industry demands and skill requirements. An "Advanced Excel Workshop" was proposed with the aim of refining students' employability skills.
- The Calendar for Mid-term examination was presented for discussion. The board advised to circulate the mid-term examination calendar well in advance among both faculty members and students to ensure effective planning and preparation.
- The board appreciates provision of make-up test. The members suggested the conduction of remedial classes to assist students in their academic progress. The proposal to incorporate the scheduling of remedial classes within the Accsoft system was well-received and acknowledged by the members.
- The board recommended the initiation of e-content development to enhance access to teaching- learning materials for students, thereby promoting a more comprehensive learning experience.
