- Last Meeting minutes held on 25th September, 2021 were confirmed.
- The Academic Council ratified and approved the minutes of all Board of Studies. Council suggested updating the course curriculum of all the programs as per industry needs. The UG programs to be updated according to NEP 2020. The value added courses proposed by the board were appreciated and approved for inclusion in the internal components.
- External and internal panel members for setting question papers were approved. Council
 suggested adding external moderators for the screening of question papers set by the
 faculty members. Council emphasized on the inclusion of external experts in the
 committee.
- Admission plan for the session 2022-23 was shared amongst the council members. Members suggested promoting the programmes among students of different regions across the nation. The council advised to plan course specific webinars with key alumni to promote the courses.
- Dr Navita Nathani reported the successful conduction of the ATAL FDP on "Design Thinking" held during 7th to 11th December 2021.
- Successful accomplishment of Webinar sponsored by National Commission for Women on "Deface the Acid Attackers: Resilience against Violence" on 30th Dec, 2021 by Mr. Aakash Gupta was reported.
- The conduction of 13th International Conference in collaboration with AIBPM held in hybrid mode was reported. The members appreciated the institute for the efforts to continue the academic rigor.
- The preparation of Advance Excel Workshop to be held during April 8th 13th, 2022 was reported. The Doctoral Colloquium conducted on 18th Dec, 2021 guiding research skills and Entrepreneurial awareness program (to be held on Feb 24, 2022) highlights were also shared with the Council.

- A report on faculty publications with around 32 Scopus and 6 Web of Sciences
 publications was presented. The disbursement of research incentives to the faculty
 members for these quality publications was appreciated by the Council. Provision for
 providing more financial assistance for research promotion was also acknowledged and
 forwarded for approval.
- The council approved the Research policy 2022 for promoting the research interest among faculty members, which includes incentives for publications in Emerald/Sage/Springer/Routledge/SciPress/InderScience/Wiley/Blackwell/Elsevier/IEEE /Science Direct/ and Taylor & Francis. The policy also highlights maintaining ethics in the research report writing.
